Roselawn - reports a good summer school with over 150 students participating. "All went well."

C. Superintendent:

State Budget Update - Joint Finance Committee Proposes:

- 1.New spending for K-12 over 2 years proposed at \$128M (Gov. Evers requested \$1.6 B) -MN proposed and should pass a \$20.8 B increase, providing a 2% increase to the general education budget each year.
- 2.SPED reimbursement increase from 28.2% to 30%

The JFC proposal now goes to the Legislature for voting. The Assembly should vote first and then the Senate.

Whatever is passed goes to Gov. Evers. Governor Evers holds line-item veto authority.

Dr. Johnson agrees that the year finished strong. Said teachers and administrators are taking time off now which they all deserve after this past year.
