# Regular Meeting

### Communication:

A. Administrators:Nelson reports that last Monday the MS team met to review the tier 1, 2 and 3 process and intervention. Tier 3 is the most intense intervention and possible learning disability needs may be found here. Fjelstad and Nelson received an email from a junior student requesting that the school have an ESports team. Due to timing agreement was made to pilot a club this year giving more time to look into potential cost, needs, etc. of having an actual team for future years. Reports that Thursday there will be an assembly to honor and hand out academic letters or pins to those students who had a GPA of 3.5 or higher for all three trimesters last year. Will also acknowledge Honors Choir and regional SkillsUSA students. Plan in January to look at opportunities for students to be able to come to the IMC area to have a few more freedoms such as hanging out with friends, listening to music, etc. after they have completed tasks and maintained grades. Also an Art Grant of \$500.00 was awarded to Mrs. Fredrickson which she plans to use for new supplies for new projects such as crocheting and macrame.

Kowalski states that last Friday Roselawn had their Reindeer Shop. He describes it as community members, businesses donating items to the shop. The children are then able to shop, for free, to pick out three items for family members to give as gifts for Christmas. Jordyn Anderson (varsity volleyball coach and para at the schools) brought this idea over from Rib Lake, Minnesota this year. Grades 4K-5th were all able to participate. There were close to 2,000 gifts donated with 150 local gift cards. School counselor, Chelsi Jenness, taught students about the importance of giving in lessons prior to the event. - \*Health Insurance Options due to IRS Changes (from November meeting)
- -The rule for HDHP's: if the plan has an **EMBEDDED** deductible, which is when one person needs to meet only the single deductible, **then the single deductible must be at least the minimum family deductible.**

- -All HDHP's in the Cooperative currently have an embedded deductible
- -All these do not include any additional District contributions to employees' HSA's. [(\$100-Single, \$200-Family = \$17k); (\$250-Single, \$500-Family = \$41k)]
  - -With the minimum family deductible moving to \$3,200 in 2024, here are the options:
- \*Option 1:Keep the \$3,000/\$6,000 family deductible <u>until July 1, 2024;</u> then change to a \$3,200/\$6,400 family deductible
- \*Option 2:Change to \$3,200/\$6,400 family deductible on January 1, 2024 with no additional HSA contribution
- \*Option 3:Keep the \$3,000/\$6,000 family deductible, but change to a **non-embedded deductible** 
  - \*Option 4:Consider changing to a higher deductible like \$4,000 single/\$8,000 family

Option 2 was chosen.
