#### A.Administrators

Mr. Nelson reports that Saturday was graduation, a "really nice ceremony for an exceptional class." Friday was the Senior Class Trip that had to be changed at the last minute due to weather, so they went to MOA. The seniors had a great time, and there was an exceptional turnout despite the plan change. An 8th-grade ELA teacher has been hired. 6th-grade students go on a field trip tomorrow. Next Wednesday, the entire MS is going on a trip. The credit recovery program for math and English has been finalized. It will take place three weeks in the summer, from 8:00 a.m. to 11:00 a.m. Monday through Thursday. Admentum will provide the instructors who will monitor the students.

Mr. Kowalski starts by saying, "Thank you for staff appreciation week." Reports that Hamilton played a significant role in it, and he wanted to thank her also. Summer school June 10-27th has the most students signed up in the last seven years, with 180-190 children/week. 4K Graduation for the class of 2037 is this week. Kudos to Mr. Nelson for changing how 6th-grade orientation will occur this year. Reported that current 5th-grade students will shadow a 6th-grade student through their regular class periods and meet the teachers they will have next year. One 5th grade classroom will go to the MS on three separate dates so there are smaller class sizes, and they can experience more things.

Mr. Fjelstad reports that the Boys Golf Team won sectionals last night as a team and will be going to State! A relay team and Thor Sather will go to State for Track and Field. Baseball ended their season last night against St. Croix Falls. Summer strength and conditioning sign-ups are out now. Graduation on Saturday was "one of the best" he's seen. Last time, the coaches voted on moving to the Dunn/St. Croix Conference was held in March 2024. Mr. Fjelstad decided to have the coaches vote once again now that there has been more time to consider the changes. These results will be brought to the BOE before the BOE votes to move or remain in the Heart of the North Conference. The track's blacktop is from 1989, so that has to come up entirely and start over to fix the track.
