Motion by Lentz, seconded by Olson to approve the April 26, 2021 agenda. Motion carried unanimously.

Wendy Newman addressed the Board. Stating she is a part-time library aide and has a daughter in middle school. She wants to "thank" the Board and administrators for making a decision "based on science" in regards to students continuing to wear masks. Highlights that with what the school has chosen to do since September, 2020 the children have been "in person learning without outbreak." Told a story of a 14 year old girl who has a severe case of COVID-19. Continues to say that the public made a "clear" decision on what they feel is the right choice for making tough decisions when they "reelected recumbents Janene Haselhuhn and Carri Traczyk" to the two seats available in the April 6, 2021 election keeping the board intact. Thanks the Board and Dr. Johnson again.

B.Administrators- Larry Zeman reports that they just had Prom this past weekend and it was a huge success. Wants to thank Liz Chelckski who is Prom advisor and all those that worked so hard to make the Prom go as smoothly as possible. Also reports that state testing is almost done. WI Forward testing is done and ACT Aspire will be done tomorrow. Reports that 53 students will be taking 95 AP exams, and that's the most the school has had.Reports that Senior Awards, Top Scholars Banquet, field trips, and Graduation are all on track to happen yet this school year. A 13 member team volunteered their time to come up with Student Experiences Supported by Learning Theory. He wants teachers to be using this as a guide. Handout was given to the Board members.

**Scott Kowalski** stated that they completed Kindness Week at Roselawn with the focus being on the community. He said the food drive they had "went over very well." They sent cards to police officers in town along with firefighters, nursing home residents and others. He also stated that they are done with their hiring process which he said is quite rigorous, starting with a school tour, have each candidate teach a demo lesson to students and then followed by an interview. Wisconsin Forward Testing will be done soon. Field trips and the 5th and 6th grade softball tournament will be back this year.

**Linda Zeman** explained that we don't have perfect testing numbers this year. She states that because some of those choosing virtual did not feel comfortable coming into the school for state testing our

numbers will not show true student performance. On a different note she had a parent of a student comment on how thankful she was that the Board made the decision to stay with masks the remainder of the year. She said because her son is immunocompromised she would not be able to have him in, inperson learning without masks.

C. Superintendent- **Mark Johnson** started by reminding everyone that a year ago today everyone was at home with no idea what was in store due to COVID-19. He commended administrators, staff, and students for all the work that has been put into making this year happen. He says it's "immeasurable" and makes him "incredibly proud".
