Communication:

A. Administrators: Larry Zeman reports it's been a "great start" to the school year, and has had roughly a dozen new students to the district start so far. Reports that with advanced placement classes and tests there have been two main goals. One is to maximize the number of students taking the classes and increase the test scores. Some schools nominate students to do AP classes, but CW does not. Also reports that this is the highest number of students taking AP classes to date and reports last Spring 81 AP exams were taken. Currently 8 AP courses are being offered. Commends the AP teachers. Also wants to highlight Mrs. Sather had 7 students in the spring and had the highest average test score at 3.43. States that Mrs. Odegard had 16 students in AP Bio and had the second highest average test score at 2.81. Another goal is to have 100% of students be involved in some kind of club so this year every high school/middle school homeroom teacher will lead some kind of club (hands out the CW HS/MS Club Schedule). Every Thursday every student will have an opportunity to participate in a club.

Kowalski states "great start as well" to the school year. Reports it started with a two day inservice on literacy training. Reports screening started for baseline on literacy. Also reports a lot of new families coming into Roselawn also. States 84 students in the kindergarten class.

Nelson starts by commending staff for a "very nice start to the school year." Reports that this year they started a new program called the Safety Patrol to help with student safety at the beginning and end of the school days. 7-8 students will be trained for this program. Reports that 57 students have signed up for the food shelf program so far. That is the program where food is sent home on the weekends with students that are in need of meals over the weekend.

Linda Zeman had nothing to report and Fjelstad reports that there are no home athletic events this week.
