Communication:

Elementary- May 6th was Success Day at the school. Parents came throughout the day and it was a huge success. Benchmark testing completed with a meeting tomorrow with RTI team. Reading Carnival put on by the 5th grade is scheduled for Thursday. Summer school registration is up and running. Numerous classes need additional help due to class sizes, which is wonderful.

High School/Middle School<u>- High School</u>: Last concert was this past week. Banquets being held including the Top Scholar Banquet. Graduation practice will be Thursday and Senior Class Trip on Friday. Graduation ceremony will take place Saturday at 7:00pm. <u>Middle School</u>: June 3rd the 5th grade class will come to the middle school to get acquainted with staff, lockers, etc. That same day the 6th and 7th grade classes will be going to Haugen for the day then returning in the afternoon for an award ceremony. The 8th grade class will go to the ropes course at Stout. Their 8th grade Graduation will be later that evening.
