Guaranteed and Viable Curriculum and Student Friendly Grading Report-

Ceil Marc and Kayla Davis presented on the Guaranteed and Viable Curriculum at the Elementary level. It is a curriculum available to all students in the least restrictive environment. All teachers have the same learning goals and expectations. If children don't master the power standards, then they will receive an intervention to increase their achievement in the specific curricular areas. Teachers received professional development in Math last year and the K-5 grades aligned the Power Standards. This helped identify gaps between grades. Teachers continue to develop common, formative, and summative assessments. This process is evolving as changes will continue to be made to improve instructional practices.

Larry Zeman, Brian Chuchwar and Bennett Koenitzer presented on the Guaranteed and Viable Curriculum and Student Friendly Grading at the secondary level. The student and teacher perspectives shared that the use of Learning Targets is improving the quality of instruction because students are accountable for fewer Learning Targets but Targets are more focused. Students are more accountable for their learning. The grading practices were shared showing that grading has changed where learning is the focus and grading on non-academic items is decreasing or non-existent.

Motion by Springer, seconded by Reisner that based upon the information provided, the Board finds that the organization and the Superintendent are in compliance and making progress toward achieving the desired results. Motion carried.
