Elementary- Author Katie McKy presented at Roselawn to encourage student writing. Groups have been established for the RtI Tier two and three based on data from MAPS testing.

Middle School/High School- The second trimester is ending. Playoffs for basketball are beginning. The four wrestling athletes who were at Sectionals are moving onto State competition. Students are preparing to present the play "Sherlock Holmes." A School Improvement Plan was presented that will take the middle school and high school through 2015-2016 school year. Student Board Representative- The first meeting of the Superintendent Student Advisory Committee met. There are seven students from the middle school and high school. They would like to see more middle school involvement to integrate with high school. Lunch options were discussed. The group would like to have more marketing of class offerings especially for AP and college courses.

District- Regarding snow days, with six days of school missed so far this year, one of those days needs to be made up. A State Legislative Bill that opposes Common Core State Standards is moving through the State level. Another Bill that addresses the 180 day school year to allow a more flexible starting date and the number of days in which school is held each week.

Bob Morehead from the Tech Ed Department presented on the progress being made on the purchasing of equipment. Local industry partners were invited in to discuss the work they do and resources they have available. WITC will be the provider of curriculum so students will receive credit for courses they take. Students have been successful with the welding tests they are taking. Students competed at Skills USA and received first and second place.

Mark Johnson presented on the Community Outreach Plan which was developed based on a survey that was given to parents and community members. Social media is being used more to broadcast information, activities and events that are taking place in the district. The overall reaction to the changes has been positive.
