Regular Meeting January 28, 2013

Meeting called to order at 5:35 p.m. by President Carri Traczyk.

Roll Call

Grover, Haselhuhn, Reisner, Wierzba, Traczyk, Jost were present. Springer was absent.

Motion by Wierzba, seconded by Grover to go into closed session at 5:35 p.m. On a roll call vote. Motion carried.

Motion by Grover, seconded by Traczyk to go back into open session. Motion carried.

Communication: Ms. Marc talked about the PBIS flag football celebration on February 1 at 12:00 in the HS gym. Parents are invited. Linda Zeman is hosting many schools that are visiting the special education department. Dr. Brown talked about the WASB Convention in Milwaukee that he attended along with Tammy Lenbom, Janene Haselhuhn and Carri Traczyk.

Laurine Karsten's gave a report on Gifted and Talented and proposed to add a Gifted and Talented 20% - 25% FTE teacher in the Middle School. Motion by Grover and seconded by Haselhuhn to accept the report. Motion carried.

Jessica Deringer, Food Service Director, gave a report on food service. She does not recommend further nutritional restrictions beyond the federal guidelines and next year predicts we will need more staff as more fresh foods are being prepared from scratch. Food cost will likely increase as well. Motion by Reisner, seconded by Haselhuhn that with respect to EL-16, Health and Nutrition, the Chetek-Weyerhaeuser Area School District Board of Education concludes that the Superintendent's Performance during the previous reporting period has been in Compliance. Motion carried.

Projected 2013 enrollment is 1049 and the projected mill rate is \$11.21. Adjustments can be made to change the mill rate in the future. Motion by Jost, seconded by Wierzba to approve budget assumptions #3 enrollment, #11 transportation, and #13 superintendent discretionary fund as presented by Tammy Lenbom.

Motion by Wierzba, seconded by Jost that with respect to El-6, Employee Evaluation, EL-7, Budgeting/Financial Planning, EL-8, Financial Administration and EL-15, Learning Environment, the Chetek-Weyerhaeuser Area School District Board of Education concludes that the Superintendent's Performance during the previous reporting period has been in Compliance. Motion carried.

Motion by Haselhuhn, seconded by Wierzba that with respect to GP-8, Board Member's Code of Conduct, the Chetek-Weyerhaeuser Area School District Board of Education concludes through self-assessment its performance during the previous reporting period has been in compliance. Motion carried.

Motion by Wierzba and seconded by Grover to authorize the issuance and sale of \$664,000 Taxable General Obligation Refunding Bond as stated in Resolution #1. Motion passed unanimously.

The City of Chetek is looking for a commitment from the school district on a softball field project. Dr. Brown will set up a joint meeting with the city council to discuss the project.

A discussion was held on the 403B Plan by Dr. Brown and Ms. Lenbom. The Board and legal counsel determined the plan to be meeting legal requirements. We will be doing a required actuarial study which will tell us the cost of the program. Motion by Jost, seconded by Wierzba to approve the 403B plan. Motion carried.
