Communication:

Elementary- Ceil Marc reported that students are staying focused during the last few days and they had great behavior on their field trips. The Destination Imagination students performed well at their competition.

High School- Larry Zeman congratulated the seniors on a great year. Jamison Wendlandt reported on happenings at the HS. Students competed in 35 events at the State Solo Ensemble Festival at UW-Eau Claire. Olivia Jensen received the highest award available at the State level which is the Exemplary Soloist award on her Musical Theater piece. The Spring concert was a success. Prom was a success and everyone was safe. Student Council held elections with Quinn Steiner, President; Heather Zeman, Vice President; Sarah Elsner and Taylor Hoesly are representatives. Give Back Day touched the communities of Weyerhaeuser, Chetek and Sand Creek and many projects were worked on. The Sophomore scores for their testing were some of the highest in the Heart of the North conference. Indiana Thompson did very well at Golf Sectionals at Turtleback Golf Course and he missed going to state by 1 stroke. The Track sectionals were held last weekend and Walker Olson made it to the State Track Meet.

Special Education- All Universal Screening data is in and students have been identified for interventions.

District- Al Brown reported on the General Aid Calculation for Consolidated School Districts proposal that is going through the Joint Committee on Finance. There are two alternatives being proposed that would increase the amount of consolidation aid that districts receive in the sixth year. Jessica Deringer, Registered Dietician, will be contracted to the Bloomer School District for 80 days next year to assist them with their Food Service Program. Al is currently developing a Transition Plan for moving to our new Superintendent in the areas of Human Relations, Public Relations, Strategic Planning, Finance, Goverance and Professional Development.

Welding and Machine Tool Program and Facility Updates-

Bob Morehead and Scott Seminson presented on areas and equipment that need to be upgraded for the Welding and Machine Tool Program in order to add rigor and accountability, close the skills gap of our students, increase the skills for the students who go directly into the workforce from high school, and to increase career and technical education opportunities. Three applications were denied due to financial hardship that would be placed upon the district for costs associated with meeting special education needs. Motion carried.

Tammy Lenbom presented the first draft of the 2013-14 budget. Motion by Springer, seconded by Haselhuhn to approve the first draft of the 2013-14 budget. Motion carried.
