Communication-

Elementary- Homecoming activities are being coordinated with the high school activities. There will be a first annual Homecoming Dance . The Pride Wall is filling up. Students are finished with their fall testing and benchmarking. Middle School-Homecoming activities for students to show spirit and pride for district are being well received. The MAPS and AIMS testing is complete. Analyzing of test results will be taking place to determine which students need interventions. High School- It is Homecoming Week with a lot of festivities including a volleyball game, a football game, a parade, a bonfire, and a powder puff football game. Staff are working on building individual learning plans for students.

Special Education- The District Report card will be available soon.

<u>School Board-</u> The WASB Regional Meeting will be held on October 16 at the Heartwood Conference Center in Trego. Board members should call the district office to make reservations.

<u>District-</u> The final figures were presented for making field improvements to the Baseball field and Football field Practice Field. The total cost was \$48,389.39. This was \$333.39 over budget.

3rd Friday Count- The preliminary student count as of 9/21/12 is 1058. We are down 29 students from the 2011-12 school year. Student totals are averaged so there will not be a significant decrease in funding this year based on enrollment. The final count will be emailed to board members.

Motion by Grover, seconded by Reisner to approve the Support Staff Contract for 2012-13 that includes a total amount of \$2,141. and \$5,990 for child care workers, the teacher's Professional Agreement Contract for 2012-13 with an increase of 3.16%, the Handbook Revisions for Coaching and Extra Duty, Substitute Custodians and Kitchen Workers and Recess/Lunch Duty Pay and a Lane Change Request for Shannon Carr. Motion carried.

City Softball Project- Information was presented on the city's plan to move the softball field to Gotham Park. City officials have approached the school district to create a partnership. A study has been done to provide a base line for the funding that is necessary for the project.

The regular meeting was recessed for the Annual Meeting and Budget Hearing at 7:00 p.m. Motion carried.

The regular meeting was resumed at 8:05 p.m.

A PBIS (Positive Behavior Intervention and Supports) presentation was given by Linda Zeman, Ceil Marc and Bryan Yenter. They introduced the audience to the expectations for students in a variety of settings (i.e. bathrooms, hallways, lunchroom, classroom, hallway, bus, etc.) in the school environment.

Motion by Reisner, seconded by Jost that with regards to Policy R-2 Academics and Knowledge regarding the PBIS Report, based upon the information provided, the Board finds that the organization and the Superintendent are making reasonable progress toward achieving the desired results with the request for a brief trimester report. Motion carried.
