Ken Jost addressed the Board on areas to focus on including future consolidations, refinancing the balance of the debt, being more visible with regards to policymaking decisions, and move forward with PEP grant initiatives on food and nutrition.

Members are reminded to provide feedback on the Board Docs so it can be used to its fullest. Roselawn-The enrollment is up by 14% from last year. The REACH grant that was a part of the Weyerhaeuser district will be carried out in the consolidated school district for the third and final year. High School-The CW homecoming was a success. Students are gearing up for the WKCE testing. The first ACT prep session was held with 25 students signed up.

Jill Koenitzer presented the Language Arts Monitoring Report. Key findings from the report include the State adoption of the Common Core Standards that will be integrated into the CW curriculum in the next 3-5 years. The selection process for a new Reading/Language Arts series for Kindergarten-6th grade will be done during the 2010-11 school year with an adoption for the 2011-12 school year. Common Formative Assessments for language arts are developed to help teachers guide student instruction. Motion by Springer, seconded by Witthuhn that based upon the information provided, the Board finds that the organization and the Superintendent are in compliance and demonstrates exemplary progress toward achieving the desired results. Motion carried.

The Enrollment report was presented. There are 1,116 students attending the CW Area School District as of September 17, 2010.
