## **Special Meeting**

Meeting called to order at 5:02 p.m. by vice-president, Dave Bonczyk.

Roll Call:

## **Open Session - Information and Action**

A. Mental Health Program Update (Hinnenkamp/Zeman/Volker/Jenness) Power point presentation given. Currently Hinnenkamp has 17 students that she sees (10 high school/middle school and 7 elementary) with 5 current students in the intake process (3 high school/middle school and 2 elementary). Top reasons students are being seen is for trauma of some kind (the majority has more than 1 trauma in their life already), depression, anxiety, suicidal ideations, and family dynamic issue(s). There is communication between Hinnenkamp and classroom teachers on an as need basis, but only necessary information is shared in order to help the classroom teacher to better teach the student. Specific discussions between Hinnenkamp and the student are held by medical confidentiality laws (HIPPA). Only Hinnenkamp can do the assessments, diagnose, and write a treatment plan which makes the intake process slow and time consuming. Volker and Jenness still see students that are in need of help, but are not as critical as the ones Hinnenkamp sees. It is also explained that Hinnenkamp is considered an intervention, so that if these students need more help than what we can offer here and need to be referred on this is still one more step for the student to progress through. Hinnenkamp is fairly booked at this time with the students that she is seeing, but hopes are once the intact process is completed more referrals will be taken. The students seen currently are being seen more frequently than what other students may need based on diagnosis. This program is constantly being revised and reevaluated. More updates will be given as needed/requested.
