July 27, 2009

Meeting was called to order at 5:32 p.m. by President Dave Peters.

Motion by Witthuhn, seconded by Jost to approve the agenda. Motion carried.

Motion by Jost, seconded by Peters to adjourn into closed session. On a roll call vote motion carried.

Motion by Springer, seconded by Jost to go back into open session. Motion carried.

#### Communication:

Jill Koenitzer reported that Summer School is complete. Two of the four teachers are hired for the 2009-2010 school year.

Al Brown reported on the PEP grant to create a program with lifelong activities and nutrition. The structure is being put together with a coordinator to be hired. Almost \$1 million will be awarded over three years.

The Booster Club and Scott Cunningham are putting together a proposal to improve the baseball field.

Larry Zeman said all schedules were sent out in June. The AP exam scores came back 7 of 17 exams received a passing grade. Over 20 students finished credit recovery courses during Summer School. Brandon Zeman returned from Washington D.C. from a Student Leadership conference where he focused on Pre-Law. He was voted as the best lawyer out of the 53 students attending.

Linda Zeman reported on the training, Read 180 and Smart Board, that will be taking place with staff.

Motion by Jost, seconded by Peters that with regards to GP-3, Board Job Description, GP-8, Board Members' Code of Conduct, and B/SR-2, Unity of Control, the School District of Chetek Board of Education concludes through self-assessment its performance during the previous reporting period has been in compliance. Motion carried.

Motion by Springer, seconded by Witthuhn that with regards to EL-12, Criterion-Based Academic Program, EL-13, Instructional Materials Selection, EL-7, Budgeting/Financial Planning and EL-8, Financial Administration, the School District of Chetek Board of Education concludes that the Superintendent's Performance during the previous reporting period has been in compliance. Motion carried.

The resolution for a line of credit was tabled until the annual meeting.

Earl Grover provided information on why he would like to fill the vacant position on the Board. Motion by Bilodeau, seconded by Reisner to appoint Earl Grover to the School Board. Motion carried.
