Motion by Jost, seconded by Johnson to approve the agenda. Motion carried.

Motion by Witthuhn, seconded by Jost to go into closed session. On a roll call vote, the motion carried.

Motion Springer, seconded by Jost to go into open session. Motion carried.

Communication:

Administration: Al Brown needs Board members to commit to whether they will be attending the WASB convention in January. The teachers received their retro payments for September 07-November 08. Roselawn: Jill Koenitzer indicated that two children have tested positive for Pertusis (whooping cough). The school has been disinfected to try to prevent other children from getting sick. WKCE testing is complete. The results from the Parent Survey showed 94% of parents in favor of what the survey asked. This was a 7% increase from the 2006 survey. Middle School: WKCE testing is complete. Some 7th and 8th grade students went to Shell Lake for Honors Band. The students had a positive reaction to the opportunity to perform with other students from the area. A 6th grade student initiated a book swap that will be conducted the week of December 1-5. High School: The resource period continues to be an area of focus. There will be some modifications for the 2nd trimester. The HS has a Ski Club. 40 students were present for the first meeting. The ACT prep session was well attended. There are 22 students interested in starting a drama club. A scholarship list was emailed out to encourage students to apply.

Board Members: Ken discussed the resolution packet that was distributed at the Legislative Issues Conference. The resolutions will be discussed at a December meeting to provide direction.
