Meeting called to order at 5:15 p.m.by vice-president, Janene Haselhuhn.

Communication:

A.Board Members- Reisner reports being asked by community members why there can be sports but no clubs at school? Dr.Johnson reported that there are 30-40 clubs which involve roughly 200 children that would rotate and be mixed during club meetings. Football and volleyball roughly involve 29-30 children in each sport and that is consistent. Due to the need for contact tracing possibility clubs would be too difficult to follow at this time. He does report that clubs that can be done virtually are being done such as FBLA, etc.

B.Administrators-Kowalski reported that the school year has had a pretty good start. He is very "proud of the staff, students, and families" for cooperating with the plans in place and following the rules set. States that they are adhering to the cohort model. Reports that at the start of the school year 73 students were doing virtual learning, but now 36 are currently using the virtual learning option. When families were asked why they changed, many said they were "surprised by the expectations" and they "felt comfortable" with returning after seeing how the beginning of the year went.

Nelson reports they have had to adjust the drop off and pick up of students by parents due to the quantity. He stated that from last spring to this fall there are 212 fewer students riding the bus in the morning and 185 fewer students riding the bus in the afternoon.

C. Superintendent-Compliments the administration for a well thought out plan for reentry back to school. States "staff, students, and families have been excellent" with all the changes this year. He reported that he has received many compliments from families from our district and other districts regarding the "live lessons" and how well the teachers have handled the change to teaching this way. Reports that the custodians have done "exceptionally" well with keeping the school clean. He is "very proud" of the first few weeks of the new year. He does report there is one positive Covid-19 case in our district as of today, but plans were in place to handle it, and everyone cooperated.
